

Filing Regulation information

Regulated information to be filed with the Central Bank of Ireland (the "Central Bank") under the Transparency (Directive 2004/109/EC) Regulations 2007 and the Central Bank (Investment Market Conduct) Rules 2019 should be sent by email to the Central Bank (the "Submission Email"). Details of the email addresses to which the Submission Email should be sent are set out on the Central Bank's website.

The Submission Email should include as attachments:

- the regulated information which is being filed with the Central Bank; and
- a completed submission template.

The Submission Email should contain only one filing of regulated information.

A Submission Email submitted without the relevant submission template will be rejected. Please ensure the most recent published submission template is used.

Submission Template

The following submission templates are published on the Central Bank's website:

- TR-1 Submission Form
- Regulated Information Submission Form.

Instructions for Completing Submission Templates

1. TR-1 - Submission Form

This template should be used by both shareholders and issuers when filing a Standard Form TR-1 – notification of the acquisition or disposal of major holdings.
